### **Free Home Repairs for Low-Income Homeowners:**

Is your home in need of general maintenance work for example, paint, handrails, wall repairs, or grab bars. If the answer is yes, and you find it difficult to pay for these services, Rebuilding Together may be able to help you. All the work is done for free by teams of volunteers with skills ranging from novice to professional during the last weekend in April. These dedicated community members repair floors, ceilings, walls, doors, and roofs; install grab bars, railings and smoke detectors; address minor plumbing and electrical repairs; build ramps, paint, and attend to yard work.

To qualify for the program a candidate must own and live in the home to be repaired, intend to remain in the home for more than two years, and their household income must meet HUD "Low-Income" Guidelines. For example, the household income level for one individual cannot exceed \$43,050, for two people \$49,200, for three people \$55,530. Priority is given to seniors, persons with disabilities, and families with children. ### **Managed Deer Hunt**

There will be a managed deer hunt at Sully Woodlands on **Wednesday, February 11, 2009** from about **6:30 am** (first light) until **1 pm**. This hunt will be conducted on all of the parklands on both sides of Pleasant Valley Road including Pleasant Valley Golf Course and running south to just north of Virginia Run. If weather prevents the hunt from occurring on the 11<sup>th</sup>, then the back-up day will be February 18, 2009. ## Controlled Meadow Burn

The Park Authority will be conducting its annual meadow burns at the Meadow Management Area on the west side of Pleasant Valley Road south of Cox's Farm. As in previous years, the burn is being conducted under county permit and in close coordination with Fairfax County Fire and Rescue Department and the Virginia Department of Forestry. The exact date of the burn will not be known until a few days before due to need to rely on favorable weather conditions. The burn could take place as early as this **Friday, February 6**, but if the weather does not cooperate, it could **any time between now and mid March**. The meeting will be held at 6:30 p.m. in Conference Rooms 4 and 5 of the Fairfax County Government Center located at 12000 Government Center Parkway, Fairfax, VA.
